Investigative Division

The **Investigative Division** activities for the month of **October 2013** are as follows:

Case Management

20 cases were assigned during the month of **October** and currently 5 of the 20 remain open.

5 cases were closed from previous months.

Off-hour Duty Calls

3 incidents required a detective to respond in during off hours during the month of **October**.

Grand Jury Court Appearances

10 cases required the appearance of a detective at Grand Jury during the month of **October**.

Prescription Drop Box

The Prescription Drop Box was emptied on 5 occasions totally 103 pounds and 0 trips were made to Rahway to deliver the medical items during the month of **October**.
